# POSTING BAIL

Getting someone out on a bail

1. When the arrestee is taken to jail he/she will go through the **booking process**. This procedure can take **from 2 to 12**, even 20 hours, depending on the detention facility and on personal circumstances.
2. The arrestee has the right to get out of jail in exchange for a bail amount determined by considering the charges filed by the DA and the county's bail schedule. A King Triton bail bondsman can post the necessary sum **immediately, no matter how high it is**.
3. Once the bondsman posts bail, the release process will begin. The jail's release procedure will take **as long as the booking procedure**, provided the arrestee was not transferred to another jail.

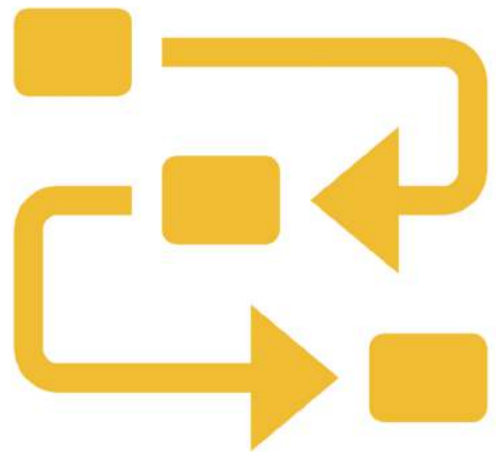
Call us **as soon as possible**.
